FINANCIAL PLAN:

Unions, local fields, churches and institutions will pay the cost of travel, accommodation, meals and registration fee for their selected attendees.

Administrators of Unions, Local Fields and Institutions as well as departmental leaders who are not financed by the organization will receive time off to participate. They shall cover their own expenses of travel, accommodation, meals and registration fee.

Local Churches shall cover the expenses of travel, accommodation, meals and registration fee for the church elder.

Church elders who are not financed by their local churches and who desire to attend shall cover their own expenses of travel, accommodation, meals and registration.

Young people and University students who desire to develop their personal leadership competences and who are able to personally finance or acquire financing to cover expenses of travel, accommodation, meals and registration fee may also attend.
