### Seven held over canning bishop

The Bishop of the Seventhday Adventist (SDA) Church of Western Uganda Field (WUF), Samuel Mwebaza, is nursing injuries after a group of Christians attacked and canned him on Tuesday.

Mwebaza was dragged out of his office at the WUF headquarters in Fort Portal town at around 1:00pm and canned.

The angry Christians, whom the Police allege were led by Jonathan Kihumuro, accused the bishop of mismanagement of church funds and failing several projects which they had initiated.

It mok the intervention of the people around the bishop's offices to rescue him as more Christians advanced towards him with sticks and stones.

Kihumuro, who is being held at Fort Portal central Police station on charges of assaulting the man of God. said several projects, including health centre have stalled

The Christians accused the bishop of mismanaging church funds and failing to run several projects which they had initiated.

"It started like drama and we didn't expect the Christians to behave like that; we thought "We tried to advise him for they were shooting a video but the Police but they arrived late," Patrick Kasangaki, businessman in Fort Portal said.

The seventh person who was arrested had not been identified by press time. "It was an embarrassment canning a bishop in public. He has reported a case of assault at Fort Portal Central Police Station and we have seven. people in custody," Tumushabe for Kabarole condemned the said.

She said the Christians stole the bishop's valuables and damaged his laptop during the scuffle.

Other incidents of assault

This is not the first time churchgoers in Uganda turn against their prelates. In February 2002, the congregation at St Andrew's Cathedral, Sesame in Kisoro were thrown into a panic when Bishop Ernest Shalita, who was in the process of sitting down, suddenly cried out in pain, clutching the seat of his cassock. Shalita, the then bishop of Muhabura Protestant Diocese, was pricked by needles believed to have been planted in his throne by unscrupulous church members.

Bishop Kityo Luwalira of Namirembe Diocese also survived being beaten when a man, clutching sticks, tried to attack him on the pulpit as he was about to start last year's Easter Sunday service. The bishop was only saved by a bar at the altar, which trapped the man before worshippers overpowered him.

"The bishop is the complainant in this case. He reported the case at Police and we immediately started investigations. We condemn such acts," Tumushabe said.

By press time, the bishop could not be traced as his phone was off and his offices in Fort Portal town remained closed.

#### Faithful eject pastor in row over changes

Faithful in 28 churches claim they are forcibly being moved to a different bishopric.

Trouble is brewing in the local Seventh Day Adventist (SDA) church after some members rejected plans to move them to new bishopric.

At least 28 churches in Nduru District, which is under South Kenya Conference, have refused to be moved to the newly created South Gusii Conference headquartered at Kenyenya.

The churches, mainly in South Mugirango Constituency, have vowed to remain in South Kenya, whose head-quarters is in Kisii town.

And on Saturday, members of Esaka SDA church ejected Pastor Rex Ondari, who is in charge of Nduru District, after he announced plans to move them to a new district, Omobera.

This disrupted the service as irate faithful forced Ondari to cut short his speech as he was booed and jeered. Nduru District comprises 28 churches.

Faithful who kicked the pastor out of the church compound said they would not be forced to join a new conference against their wish.

Boikanga MCA Joseph Chweya, who attended the service, called for calm and asked the leadership of South

Kenya Conference and South Gusii Conference to resolve the issue amicably to avoid causing divisions.

"I am calling on the SDAs top leadership to listen to what their members are saying and make a decision that would ensure there are no divisions and fights in the church so we can set a good example to the society," said Mr Chweya.

Sam Manyara, a church elder, said regulations stated that they could not be forced to join a new bishopric against their wish and asked the leadership to respect their decision to remain in South Kenya.

"Members of our 28 churches wanted the leader-ship to allow us freedom to decide where they want to be," he said.

### Court blocks SDA church from declaring eastern president

The High Court in Jinja has blocked the board of trustees of the Seventh Day Adventist Church (SDA) in Uganda from declaring the new or any other person as president of the church's Eastern Uganda Field.

A March 12 temporary injunction signed by the deputy registrar, Jesse Byaruhanga, bars the declaration of Pr James Katunzi and or any other as president.

Pr Dr Daniel Mate is the Uganda Union mission president of the SDA churches, while Israel Kafeero is its executive secretary.

The trustees, together with Mate and Kafeero, were dragged to court by the Eastern Uganda Field president, Pr Frederick Ofwono, protesting his removal from office and the consequential replacement by Katunzi.

Katunzi is the pastor of Mbale Central SDA church, which is under the Eastern Uganda Field's jurisdiction.

Ofwono was on November 23, last year removed from his seat before concluding his five-year term, which ends in 2020.

Ofwono, through Kiiza and Company Advocates, petitioned court, arguing that his removal contravened the church's policies.

Byaruhanga said the parties were given three months to sort out their differences.

He said in case they fail to reach a consensus, any of the parties would be free to notify court so that it can proceed with the main suit.

Pr Frederick Ofwono was on November 23, last year removed from his position before concluding his five-year term, which ends in 2020.

Samuel Musiho, the Eastern Uganda Field secretary, who is opposed to Ofwono's dismissal, named embezzlement or theft of funds and property as some of the grounds for sacking the president.

However, Musiho said there seems to be a personal feud against Ofwono because he was not summoned to defend himself against the allegations.

Ofwono is said to have been removed from office for

failure to manage the characters to the top leadership.

Consequently, Office opted to take legal according a judicial review of the procedures that were applied while sacking him.

However, before count on fix a date for hearing the man suit, Ofwono asked for a injunction restraining anyboth from succeeding him.

Despite the injunction applicant regretted that Max was introducing Katunza at the Eastern Uganda Peter president.

In a letter dated April 2 to Mate copied to court, Ofwom cited a workshop of Adventis Development Relief Agents (ADRA) at the Adventist Centre Makerere, where Katunzi was on March 26 introduced as the new president.

ADRA is the church's humanitarian organisation.

Ogwal, the church's union communications director declined to comment about the case. However, he confirme there was "a vacuum, though the union's executive secretaris overseeing the eastern field now".

#### SDA splinter group registers new conference

New conference was listed on March 15 and is currently operating from Maendeleo House, Loita Street.

Wrangles at the Nairobi Central Seventh Day Adventist (SDA) have divided the church as one faction registers a new conference.

Although the SDA church in Nairobi is run administratively by the Central Kenya Conference (CKC), a faction led by some elders has now created the Nairobi Cosmopolitan Conference (NCC).

The NCC was registered on March 15 and is currently operating from temporary offices at Maendeleo House, Loita Street, Nairobi.

Last Saturday, the team behind the new conference held its inaugural Sabbath at the Technical University of Kenya (TUK) and this reduced attendance at Nairobi Central Church by more than half.

#### The dispute

started late last year when the pastors and elders differed on the names to serve in the nomination committee mandated to pick officials to lead the church this year

The NCC is run by three directors, who are supported by a caretaker committee comprising 27 people drawn from churches in Nairobi and Kajiado stations.

These leaders are holding office on an interim basis until a formal election is con-

The caretaker committee has already created eight sub-committees, which are working to establish the new Conference.

The caretaker committee has been mandated to put all structures of the NCC in place and prepare for elections of the Conference officials.

Already the team has opened bank accounts, where members have been asked to channel their tithes to instead of paying to CKC.

"The membership of NCC will be both individual and corporate (churches). There will be no geographical limitations. Members and churches will be free to be members of NCC or CKC," a document seen by The Standard reads.

- Matthew 18
- Solve problems closest to their origin
- Types of claims exempted from procedures
- Insurance claims, marital differences, custody, estates, debt collection, theological questions, church discipline or reinstatement of membership
- Mediation- Mediator has power over process not outcome
- Conciliation-Steps outlined in policy
- Setting up a Review Committee (appeal)



#### Conciliation

- An alternate dispute resolution process
- Also referred to as Mediation
- Parties to a dispute agree to use a conciliator
- Purpose is to resolve differences
- Done by lowering tensions, improving communications and encouraging parties to explore potential solutions
- More likely to preserve goodwill between parties
- Confidential nature of proceedings
- Faster, less costly and more flexible




#### Defamation
